message from the director

Dear Brothers and Sisters,

In keeping with the call to commemorate the Year of Mercy, this year we invite parishes to deepen their connections with organizations in the community that serve those in need and at the margins. This resource manual, in its first edition, is offered with the purpose of placing the best of our Catholic and other community resources into the hands of those on the front lines at parishes. It is just one tool to help us to be better equipped and trained to respond to the needs of those within our parishes, both registered parishioners and all those who live within our parish boundaries, as well as other neighbors who come our way.

This resource manual will only be as helpful as the training, structures, and leadership that we have in place at our parishes to put it to use and to respond accordingly. Additionally, this is not merely a list for making referrals. Our emphasis at the parish must always be accompaniment: How are we walking alongside sisters and brothers in need and making sure that they not only get the phone number or resource they need but follow-through and care so that they know that they are loved? Our Office is committed to offering training and to help strengthen, form, and facilitate Life, Justice, and Peace leadership and committees to serve your parish.

In addition, towards that end, this October, parishes are invited to celebrate Life & Dignity Month. We suggest hosting a ministry fair and other opportunities to encounter the Church's beautiful teaching on the protection of the life and dignity of the human person from the beginning to the end of life. Such opportunities should engage and take into consideration the beautiful diversity of your parish, especially those members of your parish that may be marginalized, and efforts should be made to use the languages spoken in your parish.

As an example, a parish might have tables with representatives from :

- your local life-affirming Pregnancy Resource Center, Shelter, or Clinic
- Yes on Prop 62 (and No on 66) Initiative to End the Death Penalty in California
- Catholic Charities of Orange County and parish teams to promote the Citizenship Campaign
- Catholic Healthcare to share about caring for the whole person at the end of life
- Organizations serving sisters and brothers struggling with homelessness, Foster Care, Mental Health, and other ministries that serve human persons at every stage of life.

While many of the resources in the manual empower our charitable outreach as well, we always ask how we can work together to advocate for justice. This initiative is intended to welcome parishioners into a deeper understanding and practice of Catholic Social Teaching, to broaden the reach of our Respect Life and Justice ministries, and to strengthen your parish in its effective social ministry, in its witness as a community of salt and light.

We welcome feedback on this resource in order to make corrections and additions for future editions and are interested to hear how your parish engages in creative outreach during Life and Dignity Month and uses this tool throughout the year.

Sample Protocol for Responding to Domestic Violence Victims

Initial Response

"I'm sorry that this has happened or is happening to you and I am glad that you are telling me so that we can help."

"I would like to ask you a few more questions. Is the person who is abusing you living with you right now?"

"Are there children or elders in the home?"

"Do you feel safe going home?"

"Let me give you some pointers on how to develop a safety plan for you and your children."

Harm Reduction Strategies

"I want you to know that I am concerned for your safety and the safety of your children, you are not alone and help is available. This is not your fault. Please don't feel ashamed, violence between family members is common and it does not go away and often gets worse over time. It can have a significant impact on your health and wellbeing".

"There are people who can help you. I would like you to call Human Options. They are a community program that we work closely with. It would be confidential and they can tell you about many options and services that are available for you."

"I would like you to call Norma at Catholic Charities she can tell you about the many options and services available for you."

"If you feel like making a call now I can make a phone available to you." (877) 854-3594.

"If you would like to think about it let me give you this card. You can tear off the bottom number and put it someplace and call when you are ready. There will be someone there 24-hours a day. I encourage you to call soon."

"Please let me know how you are doing. If it becomes dangerous for you do not hesitate to call 911."

What is elder abuse?

Although each state has a different definition, elder abuse is a term referring to any knowing, intentional, unintentional or negligent act by any person that causes harm or a serious risk of harm to an older adult. This abuse manifests itself in many forms, including financial abuse, physical abuse, sexual abuse, psychological abuse, neglect, and self-neglect and occurs both in the community and facilities.

Red Flags of Abuse:

- Neglect
- Psychological/Emotional Abuse
- Financial Abuse/Exploitation
- Physical/Sexual Abuse

If you or someone you know is in a life threatening situation or immediate danger, call 911 or the local police or sheriff.

How You and Your Faith Community Can Fight Human Trafficking

Human Trafficking is the fastest growing illegal enterprise in the U.S. and is predicted to pass drug abuse in size in a few short years. The National Center for Missing and Exploited Children estimated that over 100,000 kids under the age of 18 are being exploited every year in the U.S. Contrary to popular belief, around 70% are U.S. citizens. The U.S. Department of Justice tells us that 82% is sex trafficking. People in the developed countries are often shocked to find out how prevalent

trafficking is occurring in their own communities. What they may not be aware of is that there are porn addicts in every community in the world which is creating a demand for sex trafficking victims.

1. Raise awareness! If you want to request a dynamic speaker or want to join our speaker's bureau, please email us at ucanfightht@throughGodsgrace.com. If you have a small group, our site has many resources to support you to raise awareness including a power point with sound that you can show to your group, visit www.throughGodsgrace.com and click on the Speakers Resources Tab.
2. Parents can go to Netsmartz.org and select "teens" and watch the free videos with their children. They are very powerful. 100% of children online will be approached by a predator. Any device can use your wifi to get on the internet so move the wifi into your bedroom and turn it off at night and take away your child's cell phone before they go to bed as predators and teen porn users are active at night. Make sure all their social media apps have privacy settings so teens are only talking to their friends. Predators are approaching teens at malls etc. How they "fish" for victims with low self-esteem is to come up to teens and state "You are so beautiful!" If the teen says "Thank you" and keeps walking, the predator knows they will be too much work to trick. If they say "No, I'm not," they become a target.
3. Over 60% of victims are from the foster care system. The most effective way to address this is to ask your pastor/rabbi to talk about taking care of the orphan during the service. Then have them invite everyone to visit tables as they leave, hosted by foster/adoptive and mentoring organizations.
4. Talk to men and youth about the dangers of viewing porn, how it rewires the brain. Fight the New Drug.org has great resources you can use. Teen porn addicts could be future clients for the Traffickers. Start a "Celebrate Recovery" program at your church to help victims of porn addiction and their spouses.
5. Flight Attendants can get training through [Airline Ambassadors.org](http://AirlineAmbassadors.org). Hotels and Motels can obtain resources through ECPAT, www.ecpat.net. Lawyers can get training through www.castla.org. On the "Resources and Training," tab, select "Legal Resources."
6. Raise awareness regarding labor trafficking, which makes up 2/3 of all trafficking in the world. For Easter sell "Fair Trade" chocolate like "World's Finest Chocolate." Offer "Fair Trade," slave free, coffee at donut sales and other social events. Have a table at your church or school fair with Fair Trade products on them, so people know where to buy them. Free2Work.org has reports for this type of table. Have a Donation Jar on the table for the International Justice Mission as eliminating corruption in the developing countries (third world) is key to saving people from this injustice. At your "Awareness" table have a flyer educating people on how to recognize labor Trafficking in the U.S. Let them know if they see someone who is working multiple shifts, 7 days a week for a nail salon, retirement home, as a dishwasher or a domestic servant, etc. and/or never leaves

their job to go home, they should call the police.

7. Get a group together and put up flyers in your community. When victims were asked why they did not run away, their response was that they did not know where they could get help. Go to the California Department of Justice website. Search for Senate Bill 1193. Scroll down to the word “model” that is highlighted. Print out the flyer and go to the businesses listed, like liquor stores and bus stations and show the owner a copy of the bill and ask them where they would like you to post the flyer.
8. Close to 100% of victims will have contact with a health professional while they are victims. At the “Rescue and Restore” website, (<http://www.acf.hhs.gov/programs/orr/programs/anti-trafficking>) select the “Rescue and Restore” tab and then scroll down to order “campaign materials” and order the one for health care professionals. Distribute them to local clinics and emergency rooms. They are free.
9. Many states have a school regulation that requires “Human Trafficking Awareness” to be taught at all schools. Ask your schools if they are doing this. Youth pastors and teachers can order the program from either i-Empathize or The A21 campaign so they have a tool to teach their youth. Teachers can learn how to recognize victims by going to www.ed.gov and search for “Human Trafficking” and then print out the brochure entitled “Human Trafficking in America’s Schools.” We also need to discourage young people from becoming recruiters by letting them know that penalties are severe, up to 15 years in prison! Recruiters are teens and young adults who the Traffickers pay to trick young people into becoming victims. We need “School Clubs” on every campus. This club can raise awareness as to how Traffickers trick young people, take on hosting Fair Trade events, put out flyers in the community, etc.
10. Invite your group to go to your city and ask them to incorporate “What does Human Trafficking look like?” as part of The Neighborhood Watch program and invite Homeland Security to train the postal workers to recognize signs of trafficking. Pressure them to close down the illegal massage parlors.
11. Your Faith Community can do a fundraiser for an organization that is helping victims like “Saving Innocence” or “The Dream Center.” They can host a drive for organizations that are protecting the most likely victim from becoming trafficked like Covenant House does. An example would be to hold a blanket drive for Covenant House with an altar and bulletin announcement stating...“Human Trafficking is the fastest growing illegal enterprise in California, having surpassed drug abuse in size in many parts of Los Angeles. Please bring your blankets next week to the table outside for Covenant House, who rescues homeless teens before the Traffickers find them. Also at the table will be information on how you can prevent a teen from becoming homeless by becoming a mentor.”

Natural Family Planning (NFP) is the general title for the scientific, natural and moral methods of family planning that can help married couples either achieve or postpone pregnancy. It is not contraception. NFP methods are based on the observation of the naturally occurring signs and symptoms of the fertile and infertile phases of a woman's menstrual cycle. No drugs, devices, or surgical procedures are used to avoid pregnancy. Since the methods of NFP respect the love-giving (unitive) and life-giving (procreative) nature of the conjugal act, they support God's design for married love!

In NFP both husband and wife are taught to understand and live God's design for married love – this will give them countless blessings! NFP methods promote a holistic approach to family planning which both respects procreation and has the potential to deepen the intimacy of husband and wife. NFP methods support reproductive health. They are good for the body. For the woman, NFP charting can even assist in the diagnosis of underlying medical problems. And, if a couple find they are having trouble conceiving, NFP information can help them pinpoint the most fertile time of the wife's cycle. The natural methods have none of the harmful side effects caused by contraception, especially chemical contraceptives (e.g. pill, injection, etc.). NFP methods can be marriage strengthening because it relies on couple communication and behavior change. When living the NFP lifestyle, husband and wife learn that they have a shared responsibility for safeguarding God's gift of human sexuality, marriage and family. They also grow in their understanding of God's will for their family size. NFP has the potential to make a good marriage great!

Billings Method of Natural Family Planning

The Billings Ovulation Method™ is a natural method of fertility management. It teaches you to recognize your body's natural signal of fertility - cervical mucus.

The methods that observe cervical mucus are commonly called the "Ovulation Method" or "OM." In NFP education, a woman learns how to identify the normal, healthy, cervical mucus which indicates the days that sexual intercourse is most likely to result in pregnancy. A number of NFP providers teach a variety of approaches to the observation and charting of cervical mucus.

Warning Signs: People who kill themselves exhibit one or more warning signs, either through what they say or what they do. The more warning signs, the greater the risk.

Talk – If a person talks about:

- Killing themselves
- Having no reason to live
- Being a burden to others
- Seeking revenge
- Feeling trapped
- Unbearable pain

Behavior – A person's suicide risk is greater if a behavior is new or has increased, especially if it's related to a painful event, loss, or change:

- Increased use of alcohol or drugs
- Looking for a way to kill themselves, such as searching online or buying a gun
- Acting recklessly
- Withdrawing from activities
- Sleeping too much or too little
- Visiting or calling people to say goodbye
- Giving away prized possessions
- Suffering from panic attacks

Mood - People who are considering suicide often display one or more of the following moods:

- Depression
- Loss of interest
- Rage
- Irritability
- Humiliation
- Anxiety

Risk Factors are characteristics or conditions that increase the chance that a person may try to take their life. The more risk factors, the higher the risk.

Health Factors

- Mental health conditions.
 - Depression
 - Bipolar (manic-depressive) disorder.
 - Schizophrenia.
 - Borderline or antisocial personality disorder.
 - Conduct disorder.
 - Psychotic disorders, or psychotic symptoms in the context of any disorder.
 - Anxiety disorders.
- Substance abuse disorders.
- Serious or chronic health conditions and/or pain.

Environmental Factors

- **Contagion** - would include exposure to another person's suicide, or to graphic or sensationalized accounts of suicide.
- **Access to lethal means** - including firearms and drugs.
- **Prolonged stress factors** - which may include harassment, bullying, relationship problems, and unemployment.
- **Stressful life events** - which may include a death, divorce, or loss of job.

Historical Factors
