Summary:

An Equipment Mechanic is responsible for inspecting, diagnosing, repairing, and maintaining various types of equipment and machinery. This role is crucial for ensuring the safe and efficient operation of equipment, preventing downtime, and minimizing disruptions to daily operations.

Responsibilities:

Qualifications:

Excellent attention to detail and problem-solving abilities. Strong communication skills and the ability to work independently or as part of a team. Ability to lift heavy objects. General computer skills Valid driver's license and reliable transportation.

Preferred:

High school diploma or equivalent; vocational or technical training in equipment mechanics preferred.

Experience:

Experience with a variety of equipment types and brands. Experience maintaining and servicing heavy equipment. Familiarity with hydraulics Diesel Engine repair and knowledge (Preferred) Knowledge of electric or battery powered engines and their components. Knowledge of computerized maintenance management systems.

Equipment:

Tractor, mower, string trimmer, blower, mausoleum lift, backhoe, utility shuttle, company auto, and/or truck as required by supervisors.

Physical Requirements/Work Environment

The job is frequently expected to lift, carry, push or pull objects weighing more than 100 lbs, without the assistance of mobile, powered equipment and at heights. Equipment Mechanics may work in various settings, including repair shops or maintenance shops, construction sites, open cemetery sites. The job may involve exposure to adverse weather conditions, noisy environments, and the need to work in confined spaces. The role requires occasional travel to off-site repairs and/or order pickups for necessary parts or equipment. Any candidates that receive a conditional job offer will be required to complete a fitness for duty examination to ensure that they are fit to carry out the duties of this role.
